New Members to the Town Board

At the Spring General Election, the residents elected Steve Olsen to fill one of the two supervisory positions which was previously held by Francis Rabas. Matthew Goetsch retained his supervisory seat by receiving the highest number of votes. Derek Rosek accepted the Town constable position after it was vacated by Steve Olsen. Incumbent, William Krueger, defeated Francis Rabas, for Chairman. All Town Board members serve a two year term with elections held in the Spring of odd numbered years.

Recognition of past Town Board Members



In recognition of Francis Rabas' past service to the Town of New Denmark, a special award was presented to him at the Annual Town Meeting for his 10 years of service as Supervisor for the Town of New Denmark. Prior to being elected Supervisor, Francis was employed by the Town as an operator of the Town tractor and cut/maintained the right-of-ways. As Supervisor, Francis significantly contributed to the maintenance of the Town roads/right-of-ways, updated road signs, and coordinated the installation of new fire numbers and culverts. STORM DAMAGE UPDATE

Sections of New Denmark were hard hit with the severe weather which passed through our Town on August 7th. Numerous buildings and trees were heavily damaged or lost due to the storm. The Town Board would like to remind residents they should submit an Informational Building Form (which is available online at the Town website) for any repairs or rebuilds for property that was damaged or lost in the storm. No fees are associated with the form, as it is for informational purposes only. This form will assist the building inspector and Assessor in determining what construction is new versus replacement.

Controlled Burns:

Residents may have the need to conduct a controlled burn of brush and debris from fallen trees and/or barns as a result of the storm damage. Prior to commencing your burn, please use extreme caution & ensure the weather conditions are appropriate. Before starting the controlled burn, it is recommended you contact the Brown County Sheriff's Department's non-emergency number at (920) 391-7450 and provide them with your address so emergency personnel are not dispatched. In addition, you should contact the Denmark Volunteer Fire Department at (920) 863-8466 and provide them with information about your burn. Thank you in advance for your cooperation.
