In order to continue this service, Curative Connections is looking for additional volunteer drivers as the program expands to our rural communities. To increase the number of drivers, Curative is **now offering an option for potential volunteers to use their own vehicles and receive mileage reimbursement.** Curative vehicles will still be available for those volunteers who prefer not to use their own vehicles.

Fall General Election / November 6, 2018

Voter Registration: The residency requirement to vote is 28 consecutive days. An elector cannot use a corroborating witness. Registration ends at 7 pm on the Friday before the Election Day and begins again on Election Day. **NO REGISTRATION** can occur on the Saturday, Sunday or the Monday before the election.

Absentee Ballots:

- All requests for Absentee ballots must be made in **WRITING** (signed and dated by the elector) and received by the Clerk no less than **FIVE** days before the scheduled election. **PHOTO ID MUST** accompany your application. Deadline for the November 6th Fall Election is **NOVEMBER 1, 2018**. You must be a **REGISTERED VOTER** to request an Absentee Ballot.
- Absentee voting begins September 24, 2018 and ends at 7 pm the Friday before the election. **NO IN-PERSON absentee voting can take place on Saturday, Sunday or Monday before the election**. Please call the Clerk, Michelle Wallerius, to schedule an appointment for In-Person Voting.
