The Town Board of the Town of New Denmark, Brown County, Wisconsin, by this Resolution, adopted by a majority of the Town Board on a roll call vote with a quorum present and voting and proper notice having been given, resolves and orders as follows:

The Town Board is authorized to enter into a public contract, as defined under s. 60.47(1), Wis. Stats., with an estimated cost of the public contract to the Town of more than \$5,000, but not more than \$25,000, to be executed by the Town Board or its agents on June 13, 2016.


The work to be done is to raze and remove the improvement on Parcel ND-17-1 located at 4712 County Highway P in the Town of New Denmark, Brown County, Wisconsin, and fill at grade all in conformity with all state and local statute or ordinance. The work is to be done before July 31, 2016.

Due to the estimated cost of the public contract to the Town of New Denmark, the Town Clerk shall publish this Resolution as a Class 1 Notice under s. 985.07, Wis. Stats., before the above noted public contract execution date of June 13, 2016, as required under s. 60.47(2)(a), Wis. Stats.


