**2021 Tax Reminders** - Tax payments can be made in person at the **Brown County Treasurer's Office** located at 305 East Walnut Street, Room

160, Green Bay: Monday through Friday from 8:00 a.m. – 4:30 p.m. or online at <u>www.browncountywi.gov/propertytax</u>. Brown County has not contract with any financial institutions for 2021, so please see your tax bill for payment information.



Please note: Dog license fees <u>cannot</u> be included in your tax payment – please direct payments with the completed application to Michelle Wallerius, Treasurer at 5993 W. Cherney Road, Denmark. An application is attached or can be requested from the Treasurer and/or is available online at the Town website under the <u>Form</u> section.

**Dog Licenses:** Dog Licenses must be purchased separately from the Treasurer and <u>cannot</u> be included in your tax payment. Pursuant to Wisconsin statutes, **all dogs over 5 months of age must be licensed**. Fees for SPAYED OR NEUTERED DOGS are **\$10.00**, otherwise the license is **\$15.00**. You will need to furnish the dog's name, sex, breed, whether it is spayed or neutered and the date and type of last <u>Rabies Vaccination</u> when applying for a license.
