ND-69 Hwy T for accessory building. MC * Renewal of building inspector contract for 2023-2025. Town to adopt \$100 administrative fee for new residential permits. *2022 Annual audit – letter of engagement approved \$6,195. * Resolution to adopt Emergency Services Cost Recovery for the Denmark Volunteer Fire Department, which would allow the department to recoup costs associated w/ accidents on I-43. Town residents would not be invoiced for services. Resolution 2022-09 approved. * Chairman Krueger states shouldering added to Pine Grove. Signed agreement required if residents want to waive Town service for removal of snow from Love Lane or Maribel Rd. * Brown County Planning issued 5148 Denmark Rd for new accessory building on Joe’s Lane. * Rezoning request for 2.2 acres from L. Cattlean property located at ND-184 (5645 Park Road) for construction of new residential home. Public hearing conducted, request is adjacent to Aspen Court, but falls outside the designated areas for future growth pursuant to the Comprehensive Plan. CSM not provided and does not contain 35 acres. Existing home on property. Motion to deny rezoning due to the guidelines outlined in the Comprehensive Plan and to avoid spot zoning. * Portion of ND-621 from Ag-1 to B-1 approved per CSM MC *Motion to approve cellular communication language for all zoning types for towers. MC *Motion to donate \$2,500 to the DYBS league for diamond improvement at Veterans War Memorial Park. 	<ul style="list-style-type: none"> * Dave Schlies inquires if CSM has been filed for revised roadway for Old Settlers Road. * Waiting for CSM from Mau & Associates to finalize agreement for Jensen Lane. Jensen Lane officially discontinued and Pro-1 to be notified they no longer need to service to the end. * Bowmar Appraisals working on exterior fieldwork. State advised about partial for new cheese factory for year end. * Denmark Volunteer Fire contract approved for \$89,238.07. * Request to have Joe’s Lane plowed. Re-ordered Fenwick Road sign and double arrow for Wanek. Written waiver submitted if resident wishes to waive right to snow removal for Love Lane. * Administrator Hafz to submit rezoning report to state and request Brown County update the official Town zoning map online.

<ul style="list-style-type: none"> *Info permit for ND-225 – 5027 S County P for foundation replacement; MC ND-285 for deck addition. MC * Assessor Gaworek reports final sales for 2022 submitted. * Motion to donate \$2,500 to the DYBS league for ball diamond for 2023. This will be the annual donation from the Town. * Discussion of speed limit on Pine Grove as New Denmark’s portion is 45 mph, Town of Eaton 55 mph. Request to consider increasing speed to 55 or posting of reduce speed ahead signs. The board feels 45 mph is adequate in this stretch due to the hills and ravines. Road signs ordered for Irish Rd. * Discussion to continue with cutting half the Town to the fence line for 2023; County Hwy R could be divider. * Escrow agreement for reimbursement of development expenses incurred \$7,484.50; Balance of escrow returned to Big Sky. * Monthly town meeting for March moved to March 6, 2023. * Request to insulate crawl space and clean out due to rodent issue. * CSM for 4878 Shirley Road (ND-634-3) CSM approved for layout of B-1 zoning on parcel Approved by Town Board on 10/10/22. Clerk to sign CSM. * Discussion of Badger Tiling invoice and work requested at land owner and installation of culverts without permits. After the fact fees can be assessed and costs doubled. 	<ul style="list-style-type: none"> * Info permit for ND-687 for accessory buildings. Motion approved. ND-522 6346 County Rd KB for new residential / combined shop. Parcel 35 plus acres, zoned Ag-1. MC ND-328 5463 Town Hall Rd for accessory building. Setbacks, zoning appropriate. MC * Revalue is a work in progress. Board of Review dates to be set at April meeting. Will need to convene and adjourn to future date. Updating Personal property forms. * Brown County will be updating the aerial mapping this spring and available online. * Request from local 4-H group to use Town Hall for future meeting dates. Board has no objection, will need to coordinate times with Board members to open and close the Town Hall for meetings. * Request from transmission wire company for upgrades along Hwy 96 and Cooperstown Rd. May have some road closure and if excavation is anticipated, permit from Town will be required. * Follow with property owner for culvert / driveway permit for Langes Corners. DNR determined culvert crosses navigable stream. Rezoning request from M. Schlies, meeting to be scheduled after April 10, 2023. * Work comp refund of \$147; April 4th Spring election and April 18, 2023 Annual Meeting of the Electors.
